

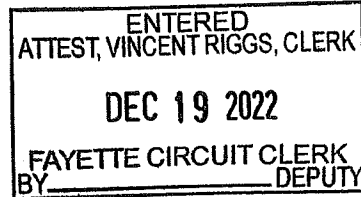

The Court having conducted an in-camera review of Counsel's invoices **HEREBY** finds the following:


1. Defendants Dr. Hore, Dr. Spirito and Dr. Rodgerson are entitled to reimbursement of \$56,014.90 previously paid to Casey, Bailey and Maines, PLLC;
2. Defendant Dr. Robert Hunt is entitled to reimbursement of \$20,212.50 previously paid to Miller, Griffin and Marks, PSC;
3. Defendant Hagyard-Davidson-McGee Associates, PLLC is entitled to reimbursement of \$46,065.00 previously paid to Frost Brown Todd, LLC

4. Defendant Dean Dorton Allen Ford is entitled to reimbursement of \$20,841 previously paid to Wyatt, Tarrant & Combs, LLP;
